PBF Committee Presentation

Good morning Chair Topper and members of the council, and thank you for allowing me the opportunity to testify on behalf of Temple University. I am Radhey Patel, a senior double major in Economics and Philosophy in the Fox School of Business and College of Liberal Arts. As a student in the final semester of my 4-year education here, I can say that being at Temple has truly defined what it means to develop my skills currently while setting myself up for the future. My near perfect GPA is a testament to the commitment of both the Liberal Arts and Fox faculty to its students. The attention to detail in lectures and assignments and making themselves readily available contributed greatly to my success. Professors here aren't simply committed to the subjects they teach but also to the mission of Temple to serve the North Philadelphia area, an idea they aim to advance.

Temple's impact on me has not just been academic, however. The abundance of extra curriculars to get involved is clear. The Temple Finance Association has been instrumental in propelling my career. It speaks to Temple's commitment to giving back to the city and developing the community to set it up for long-term prosperity, all starting with the children.
